As you are all aware, on March 27, 2017, I exercised my right of inquiry, and under the name of David Setson wrote to the Center for Personalized Education for Physicians (CPEP) located in Denver, Colorado and as well, in Raleigh, North Carolina.

Lacking a published email address, I used their Contact form to write the following:

Monday, March 27, 2017

Dear People at CPEP:

I have a friend who is is being ordered by his licensing board to go to CPEP in Colorado. I told him that CPEP has no accreditation. He believes CPEP must be accredited. He is willing to go, but I told him we should see some kind of accreditation statement before he put out all that money. I could find no indication of it on the CPEP website.

Would you be so kind as to send us some information on your accreditation?
Specifically, I am interested in knowing which accrediting bodies provide the accreditation to CPEP.

After having received no response in 5 weeks, I wrote to them again. This time, I wrote the following:

Dear People at CPEP,

Five weeks ago, I sent you the following email. It was of considerable importance as you can tell. No one responded. This is sort of what I expected. I will assume, and

publish, that CPEP is not accredited by any appropriate accrediting body until CPEP can give me any reason to believe otherwise.
